2021 WORLD MIGRATORY BIRD DAY SMALL GRANT
FUNDING AGREEMENT

THIS AGREEMENT is made on **29th March 2021** among, **The East Asian-Australasian Flyway Partnership Secretariat**, (hereinafter referred to as '**EAAFP Secretariat**') and **Student Activity Units of Veterinary Faculty, University Syiah Kuala**.

WHEREAS:

The **EAAFP Secretariat** and The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** intend to cooperate together for the benefit of the conservation of migratory waterbirds and their habitats, and in furtherance of such cooperation the **EAAFP Secretariat** wishes to contribute towards the cost of a project to promote the World Migratory Bird Day (hereinafter referred to as 'the Project') to be undertaken by The **Student Activity Units of Veterinary Faculty, University Syiah Kuala**.

IT IS AGREED as follows:

1. THE PROJECT

- 1.1 The **EAAFP Secretariat** and The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** agree to co-operate together for the benefit of the conservation of migratory waterbirds and their habitats, it being mutually agreed that the execution of the Project by The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** will make an important contribution to this end.
- 1.2 The parties agree that to the best of their knowledge and belief the Project to be funded under this agreement is for the achievement of outputs that fall within EAAFP's Objectives.
- 1.3 Attached to and forming an integral part of this agreement are:
 - Annex A containing the agreed *Project Description*,
 - Annex B containing the agreed *Project Budget*, and
 - Annex C containing the agreed *Project Payment and Reporting Schedule*,
 - which The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** hereby declares it has noted and accepted.
 - The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** undertake to adhere to Annexes A, B and C in the execution of the Project and to use the **EAAFP Secretariat's** financial contribution solely for the purposes of the Project. Any amount not specifically used for the purpose stipulated may be recovered by the **EAAFP Secretariat**.
- 1.4 The parties agree that Annexes A, B and C to this agreement can be modified when necessary through the exchange of Contract amendment letters signed on behalf of the parties.

- 1.5 By accepting this finance from the **EAAFP Secretariat**, The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** agrees to complete all the work described in Annex A that is scheduled for the duration of this agreement.
- 1.6 The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** agree to translate the necessary materials for World Migratory Bird Day in their language and feedback to **EAAFP Secretariat**, and agree that logoes of WMBD and EAAFP have to be included in all printed materials under the Project. And the event has to be registered on the WMBD website: <https://www.worldmigratorybirdday.org/register-your-event>.

2. FUNDING

- 2.1 The **EAAFP Secretariat** agrees to provide funding to The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** for the Project on the terms and conditions contained in this agreement.
- 2.2 Where the work detailed in Annex A is sub-contracted to or done concurrently with additional work supported by additional organisations, The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** holds the responsibility of notifying all parties and ensuring that there are no conflicts arising between agreed activities. The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** is also responsible for ensuring that those sub-contracted to carry out any part of this work agree to and observe in full the various conditions detailed in this document and Annexes.

3. PAYMENTS

- 3.1 The **EAAFP Secretariat** will pay The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** a lump sum for the production of the contract services and deliverables, in accordance with the Budget and Payment Schedule set out in Annex B and C. The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** will invoice the **EAAFP Secretariat** as set out in Annex C and the **EAAFP Secretariat** agrees to pay such invoices within 30 days, subject to approval of invoices.
- 3.2 If there are any Project funds provided by the **EAAFP Secretariat** which have not been spent on or committed to The **Student Activity Units of Veterinary Faculty, University Syiah Kuala**, the subsequent payment will be adjusted accordingly.
- 3.3 On expiry or prior termination of this agreement, any Project funds provided by the **EAAFP Secretariat** which have not been spent on or committed to the Project by The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** and will be repaid to the **EAAFP Secretariat** by The **Student Activity Units of Veterinary Faculty, University Syiah Kuala**.
- 3.4 Payments to be made by the **EAAFP Secretariat** may be withheld if in the **EAAFP Secretariat's** view satisfactory progress has not been made or technical or financial reports (or Partner Indicators, if applicable) of either the present or any previous funding agreement between the parties has not been received by the due date.
- 3.5 All sums payable under this Agreement by the **EAAFP Secretariat**, unless otherwise stated, are deemed to be inclusive of any duties or taxes payable.

4. REPORTING

- 4.1 The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** will provide Reports to the **EAAFP Secretariat** according to the specifications and schedule as shown in Annex C.

5. FINANCIAL RECORDS AND CONTROL

- 5.1 The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** will use all reasonable endeavours to carry out the Project in the most economical manner and in particular will source goods and services required for the Project in the most cost-effective manner.

6. DISSEMINATION OF PROJECT RESULTS

- 6.1 The parties agree that as the Project is to be undertaken for the benefit of bird conservation, the results of the Project, including the materials generated from the Project shall be made freely available to anyone with a legitimate interest in using the results for the furtherance of conservation on non-commercial purposes.

7. COMMENCEMENT, DURATION AND TERMINATION

- 7.1 This agreement will come into effect on the date written at the heading of this agreement and, unless terminated by one of the parties under the provisions of Clause 7.2 below, will expire 6 months after the final payment has been made by the **EAAFP Secretariat** to The **Student Activity Units of Veterinary Faculty, University Syiah Kuala**.
- 7.2 Either party may at any time and for any reason give not less than 3 months' written notice to the other that it wishes to terminate this agreement, at the end of which notice period this agreement will duly terminate.

8. INDEMNITIES

- 8.1 The **Student Activity Units of Veterinary Faculty, University Syiah Kuala** shall be responsible for dealing with any taxes due relating to their costs incurred whilst undertaking the project covered by this agreement.

Project Title: Webinar World Migratory Bird Day 2021 and Bird Watching

Date: 1 – 2 May 2021

This year HIMPUS is celebrating the World Migratory Bird Day 2021 which will be celebrated on 1-2 May 2021. In welcoming the WMBD 2021 celebration, HIMPUS celebrates with a series of activities for public awareness. The series is in the form of WEBINAR and Birdwatching. These activities will be carried out online and will carry out the COVID-19 health protocol. This is because in Indonesia it is still implementing government regulations in preventing the transmission of COVID-19.

1. WEBINAR World Migratory Bird Day 2021 (1 May 2021)

The Webinar WMBD 2021 will be held online with the Zoom application and Youtube Streaming. This webinar will be filled by presenters who are experts in the world of migratory birds in Indonesia. The goal of holding the WMBD celebration by holding a webinar is to foster a love for the environment and make people aware of how to protect migratory bird species and their habitats. because online media is the main alternative during a pandemic situation in Indonesia.

The target participants of the Webinar are: The general public, students, bird and environmental observers and conservation organizations in Indonesia. The range of the number of participants from the Webinar WMBD 2021 is 200 people from all circles in Indonesia.

2. Field trip, Birdwatching and cleaning trash (2 May 2021)

Field trip, birdwatching and cleaning trash activities will be held on May 2, 2021 at Ulee lhue Beach, Banda Aceh. This activity is a direct effort to invite the public to see first hand the conditions of the habitat and migratory birds in Banda Aceh, Indonesia. This activity also as HIMPUS monitoring for migratory bird habitat survey in Banda Aceh. This activity will take place by implementing health protocols and limiting the number of participants.

The target participants of the Webinar are: the general public, students and bird watchers. The range of the number of participants in this activity was 30 people.
