#### Dear Partners,

To report on the progress of the implementation of the <u>EAAFP Strategic Plan 2019-2028</u>, a Reporting Template was developed at the 10th Meeting of Partners (MOP10) in Hainan, China which was subsequently used to gather progress from Partners for MOP11 held in Brisbane, Queensland, Australia.

The EAAFP Secretariat has amended the reporting template to account for the feedback gathered at MOP11 as well as the MOP11 decisions specifically Key Results Areas 1.2 and 1.6. To streamline the process and reduce the length of the reporting document, three separate templates have been created: for (1) Government Partners, (2) Non-Government Partners, and (3) Working Groups, Task Forces, and the Technical Sub-committee.

The "Reporting Questions" are linked to Key Result Areas to enable an assessment of progress with the implementation of each element of the Strategic Plan. Indicators have been provided to facilitate reporting and assess our achievements.

As this Reporting Template was developed in alignment with the Strategic Plan, some questions may appear to overlap. However, completing them all will provide comparability with the previous <u>Partner Reports</u> submitted for MOP11.

While the total number of questions for Working Groups, Task Forces, and the Technical Sub-committee is 27, the number of questions for each Partner Group, and each mechanism of the Partnership, is shown below:

All of our activities align with Objective 2 of the CEPA Action plan, and our Working Group is guided by a workplan which prioritises actions taken directly from the CEPA Action Plan.

Following MOP11, one of the priority actions was to identify and prioritise the elements of the CEPA Action plan that should be prioritised for implementation before MOP12, this was completed by the Working Group, with feedback sought from partners to create our workplan 2023-2025.

Some of the key work areas (*in italics*) the CEPA WG have achieved from the CEPA Action plan since MOP 11 include:

- 12A Identifying and prioritising the elements of the plan that should be prioritised to implement. The CEPA WG have created a work plan 2023-2025
- 4A Identify media (including social media) groups and opportunities and provide relevant materials and support as necessary. The CEPA WG worked with journalist Christina Larson, to create guidance and run a webinar that was open for attendance by partners. Christina's guidance on media releases led to subsequent EAAFP news articles.
- 8B Coordinate national CEPA activities including organising and promoting Flyway-wide annual CEPA
  activities (WMBD grants and other resources, if avail) AND 10B Implement flyway-wide activities,
  including WMBD & WWD, at FNS. The CEPA WG acts as an advisory committee on the theme and
  supporting resources for WMBD. In addition, the CEPA WG reviews small grant fund applications that
  have a CEPA component
- Youth Task Force Creation and Support. The CEPA WG continues to work closely with the Youth Task Force and will advise the establishment of the Youth Task Force Terms of Reference for MOP12.

Various members of the CEPA WG are involved in other initiatives, especially the ASEAN Flyway Network. Some specific example include:

Co-chair Tina Redshaw presented at a webinar run by the ADB's Regional Flyway Initiative in Feb 2025.

Co-Chair Lindall Kidd presented at a meeting on Dec 2024 for the AEWA regarding the formation of a CEPA working group.

WG member David Lawrie is reworking the sister site relationship arrangement with the Yalu Jiang NN reserve in China.

WG member Vivian Fu has run the following initiatives:

- Sister Sites partnerships: Facilitation of partnerships between Mai Po and Inner Deep Bay (Hong Kong) and Songdo Tidal Flat (Republic of Korea), as well as Sungei Buloh Wetland Reserve (Singapore). Representatives from Incheon City visited Mai Po last year and this year, while Sungei Buloh WR visited Mai Po this year to enhance the relationship and discuss future collaboration.
- North-East Asian Subregional Programme for Environmental Cooperation (NEASPEC): Collaborate in updating the Black-faced Spoonbill International Single Species Action Plan, for which I am responsible for the CEPA session
- ASEAN Flyway Network: Presented WWF's work for CEPA in Wetlands during CEPA Learning Forum and Workshop organized by AFN on 7 May, 2025.
